1. Consolidated Remuneration shall be as per Level -11 as per 7th CPC (approx. Rs.1,50,939/-).
2. Agreement in the Standard Prescribed Format shall be signed and executed between the contractual Specialist and the MS/MD of concerned hospital.
3. The selected Specialists on contractual basis shall submit two original sets of signed contractual agreement within seven days of the declaration of result.

4. Any letter of resignation submitted by the contractual specialists will be treated as a letter communicating the intention of the contractual doctor to terminate the contract. If a contractual specialist wishes to terminate the contract by giving **30 (thirty) days** notice it would be accepted by the Medical Director of the institution, after getting a no dues certificate from the branches concerned. No notice is required, if service is terminated on disciplinary grounds/falsification of declared information.
5. Private Practice of any kind is not allowed.
6. Contractual Specialists are governed only by the terms and conditions mentioned in the contract agreement and not by any other rules for grant of leave benefits, LTC benefits, GPF, Pension Benefits, DGHS, Provisions of FR/SR etc., that are applicable to only regularly appointed doctors of Government of NCT of Delhi.
